2. The Author expressly acknowledges and agrees that this Agreement is entered into pursuant to the Author Agreement, all the terms and conditions apply. The Author Agreement and all of its provisions will apply equally to this Agreement. Furthermore, the provisions of the Author Agreement, to the extent they generally limit LitFire's liability and otherwise protect LitFire from liability to Author, will also apply to any third parties. In the event of any conflict between the terms of this Agreement and the Author Agreement, the terms of the Author Agreement will be controlling and take precedence.
3. The Author will be bound by this Agreement upon sending a facsimile or electronic transmission to LitFire. As to LitFire, this Agreement will be deemed to be accepted by, and binding upon, LitFire at such

time as LitFire receives confirmation that full payment from the Author for the services associated with the Program has been received and irrevocably credited to LitFire.

4. By signing, the Author acknowledges that he/she has read, understood, and approved all the terms and conditions of this Agreement and agreed to be bound by its provisions.
